Jan was instrumental in the creation of the FACES of Hope Victim Center, that provides wraparound services to crime victims - medical, law enforcement, prosecutors, social services, a law clinic for civil legal issues, among other resources, to fully support our most vulnerable residents in the aftermath of the crime.

Right now, there is an active effort to replace prosecutors across the country with prosecutors that do not uphold the rule of law. These same prosecutors base charging decisions on politics, not on the welfare of the victim or the community. Not charging crimes such as rape and child molestation, re-victimizes a vulnerable population. Jan has a proven track record supporting crime victims while providing services for vulnerable populations and holding those responsible accountable.

Electing the right person to serve as Prosecutor is a serious responsibility, and tremendously important to all citizens of Ada County. The Retired Law Enforcement Officers of Idaho believe that Jan Bennetts is that person, and we strongly encourage you to elect Jan Bennetts as our Ada County Prosecutor.
